Technical Requirements

In the unlikely event of the course switching to online delivery mode, the students will be expected to have a stable internet connection and access to a computer with working microphone and webcam.

5. Methods of Evaluation

For undergraduate students, the course mark will be based on their term work, 2 term tests, and the final exam, with the following weights:

Term Work	24%
Midterm Tests (2)	36% (18% each)
Final Exam	40%

For graduate students, the final mark will be the weighted average of the above components and the in-class presentation of a selected topic, with weights of 95% and 5% respectively.

The Term Work will consist of bi-weekly assignments or weekly quizzes (depending on the TA support), and will be announced at the beginning of the term.

The **midterm tests** will be held **in class**, on **February 13** and **March 20**. Make-up midterm tests are tentatively scheduled for February 23 and March 23.

Use of Generative AI Tools

All requests for Academic Consideration must be made within 48 hours after the assessment date or submission deadline.

All Academic Consideration requests must include supporting documentation; however, recognizing that formal documentation may not be available in some extenuating circumstances, the policy allows students to make one Academic Consideration request **without supporting documentation** in this course. However, the following assessments are excluded from this and, therefore, always require formal supporting documentation:

- **Examinations scheduled during official examination periods** (Defined by policy)

When a student mistakenly submits their one allowed Academic Consideration request **without supporting documentation** for the assessments listed above or those in the **Coursework with Assessment Flexibility** section below, the request cannot be recalled and reapplied. This privilege is forfeited.

Math 9022B students:

Submit any academic consideration requests to the instructor. These may be processed in consultation with the Math Graduate Chair.

Evaluation Scheme for Missed Assessments

Missing an evaluation component will result in a grade of zero unless appropriate permission is sought and granted.

Missed Quizzes and/or Assignments: Each student can miss up to 2 quizzes without penalty. Beyond that, students who are granted an academic consideration for a missing quiz and/or written assignment will get the other components of their evaluation reweighted. For example, if only one assignment worth 4% is missing, the course grade will be computed out of 96 instead of 100.

Missed Midterm: Students who are granted an academic consideration will get a make-up midterm exam. The tentative dates of make-up midterms are February 23 (Test 1) and March 23 (Test 2). Students who are granted an academic consideration and who are not able to complete the scheduled make-up will get their evaluation reweighted. For example, if only one midterm (18%) is missing, the course grade will be computed out of 82 instead of 100.

When a student misses the Final Exam and their Academic Consideration has been granted, they will be allowed to write the Special Examination (the name given by the University to a makeup Final Exam). See the Academic Calendar for details (under [Special Examinations](#)), especially for those who miss multiple final exams within one examination period.

6. Additional Statements

6.1 Religious Accommodation

When a recognized religious holiday or observance conflicts with an examination, test, or other scheduled academic obligation, students must request accommodation via the University's Student Absence Portal (SAP). This request should identify the conflict and specify which course component(s) (e.g. test, midterm, exam) are affected.

Students are encouraged to submit the SAP request as early as possible, but no later than two weeks before any examination, or one week before any mid-term test or quiz, to allow sufficient time for adjustment.

Use of Electronic Devices During Assessments

Unless otherwise stated, the use of generative AI tools (e.g., ChatGPT, Microsoft Copilot, Google Gemini, or similar platforms) is **not permitted** in the completion of any course assessments, including but not limited to: assignments, lab reports, presentations, tests, and final examinations.

Using such tools for content generation, code writing, problem solving, translation, or summarization—when not explicitly allowed—will be treated as a *scholastic offence*.

If the use of generative AI is permitted for a particular assessment, the conditions of use will be specified by the instructor in advance. If no such permission is granted, students must assume that use is prohibited. It is your responsibility to seek clarification before using any AI tools in academic work.
