TEXTBOOK: Openstax Calculus Volume 3.

The textbook is available for free (electronically) from openstax.org (Subjects, Math). On the website, there is an additional option to purchase a print copy.

PREREQUISITES: A minimum mark of 55% in Calculus 1501A/B or Calculus 1301A/B, or Applied Mathematics 1413.

Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

ANTIREQUISITES: Calculus 2502A/B.

COURSE DESCRIPTION: Three dimensional analytic geometry: dot and cross product; equations for lines and planes; quadric surfaces; vector functions and space curves; arc length; curvature; velocity; acceleration. Differential calculus of functions of several variables: level curves and surfaces; limits; continuity; partial derivatives; tangent planes; differentials; chain rule; implicit functions; extrema; Lagrange multipliers.

We will cover most of Chapters 2, 3, 4 of the textbook (2.1-2.6, 3.1-3.4, 4.1-4.8).

If you are unsure whether you should be taking Calculus 2302A or 2502A, please check the course prerequisites and your module requirements and/or contact an academic counsellor. We will briefly discuss the differences between the two courses in class.

WHAT IS EXPECTED OF THE STUDENT: Students are expected to attend all class meetings, review all learning materials in timely fashion, follow class announcements, complete all assignments and write all examinations. Solutions of collected homework problems must be written neatly, and handed in by the deadline.

EVALUATION OF STUDENT PERFORMANCE:

"level of engagement" component 9% midterm exam (2 hours, online, to be scheduled centrally) 31% take home final exam (24 hours, to be scheduled by the Registrar's office) 20%

ACCOMMODATED EVALUATIONS: late homework will not be accepted. Please submit any time before the deadline. If there is a proper documentation for a missed assignment, then the homework component of the grade will be adjusted accordingly. In order to obtain a passing numerical course grade, a student must write a proctored assessment. If a student missed the midterm online test and accommodation is approved by academic counseling, then a make up test will be given.

TECHNICAL REQUIREMENTS for the course: computer with a microphone and webcam, stable internet connection, a scanner or an alternative.

The remote learning sessions for this course will not be recorded. All supporting learning materials will be available on the course owl site. Attendance in remote learning sessions will be used towards the "level of engagement" course evaluation component. Some of the class meetings will rely on asynchronous course materials which students are expected to review in timely fashion.

Participants in this course are not permitted to record the sessions, except where recording is an approved accommodation, or the participant has the prior written permission of the instructor.

The *midterm examination* in this course will be conducted using Zoom. You will be required to keep your camera on for the entire session, hold up your student card for identification purposes, and share your screen with the invigilator if asked to do so at any time during the exam. The exam session will not be recorded.

The *final examination* in this course is a take home examination.

All students: you may be asked to submit your draft calculations/rough work, in addition to the clean copy of final exam solutions. Students may be randomly selected for a follow up meeting during which they would be asked to explain their solutions presented in the take home final exam.
