### 3. Course Syllabus, Schedule, Delivery Mode

The course description published in the Western Academic Calendar:

Integral calculus of functions of several variables: multiple integrals; Leibnitz' rule; arc length; surface area; Green's theorem; independence of path; simply connected and multiply connected domains; three dimensional theory and applications; divergence theorem; Stokes' theorem.

Course-level learning outcomes: on successful completion of this course, students will be able to

- (1) Recall and apply Green's theorem, Stokes' theorem and the divergence theorem
- (2) Demonstrate skills in calculating integrals that involve functions of several variables or vector fields
- (3) State the definition and indicate the basic properties of the line integral, surface integral, and an integral over a three dimensional region
- (4) Compare the theory of the Riemann integral of functions of one real variable to the higher-dimensional case

All Academic Consideration requests normally must include supporting documentation; however, recognizing that formal documentation may not be available in some extenuating circumstances, the policy allows students to make one Academic Consideration request **without supporting documentation** in this course. However, the following assessments are excluded from this, and therefore always require formal supporting documentation:

- Examinations scheduled during official examination periods (Defined by policy)
- Midterm 2 (Designated by the instructor as the one assessment that always requires documentation when requesting Academic Consideration)
- Homework assignments (Per policy; due to flexibility in the submission timeframe: a 2 week submission window)

When a student *mistakenly* submits their one allowed Academic Consideration request **without supporting documentation** for the assessments listed above or those in the **Coursework with Assessment Flexibility** section below, the request cannot be recalled and reapplied. This privilege is forfeited.

### **Evaluation Scheme for Missed Assessments**

Each missed assessment that is not followed up in a timely manner by an academic consideration request (that is subsequently approved), will result in the grade of zero for this assessment. Missed assignments: extensions will not be granted. Late papers will not be accepted after the assignment solutions are released. For students with approved accommodation, appropriate reweighting will be done. Missed midterm test: a student with approved accommodation will be given one chance to write a make up test, within two weeks of the original test. If the make up test is not written within 2 weeks and there is an approved accommodation covering that, then the mark will be moved to the final exam.

When a student misses the Final Exam and their Academic Consideration has been granted, they will be allowed to write the Special Examination (the name given by the University to a makeup Final Exam). See the Academic Calendar for details (under Special Examinations), especially for those who miss multiple final exams within one examination period.
